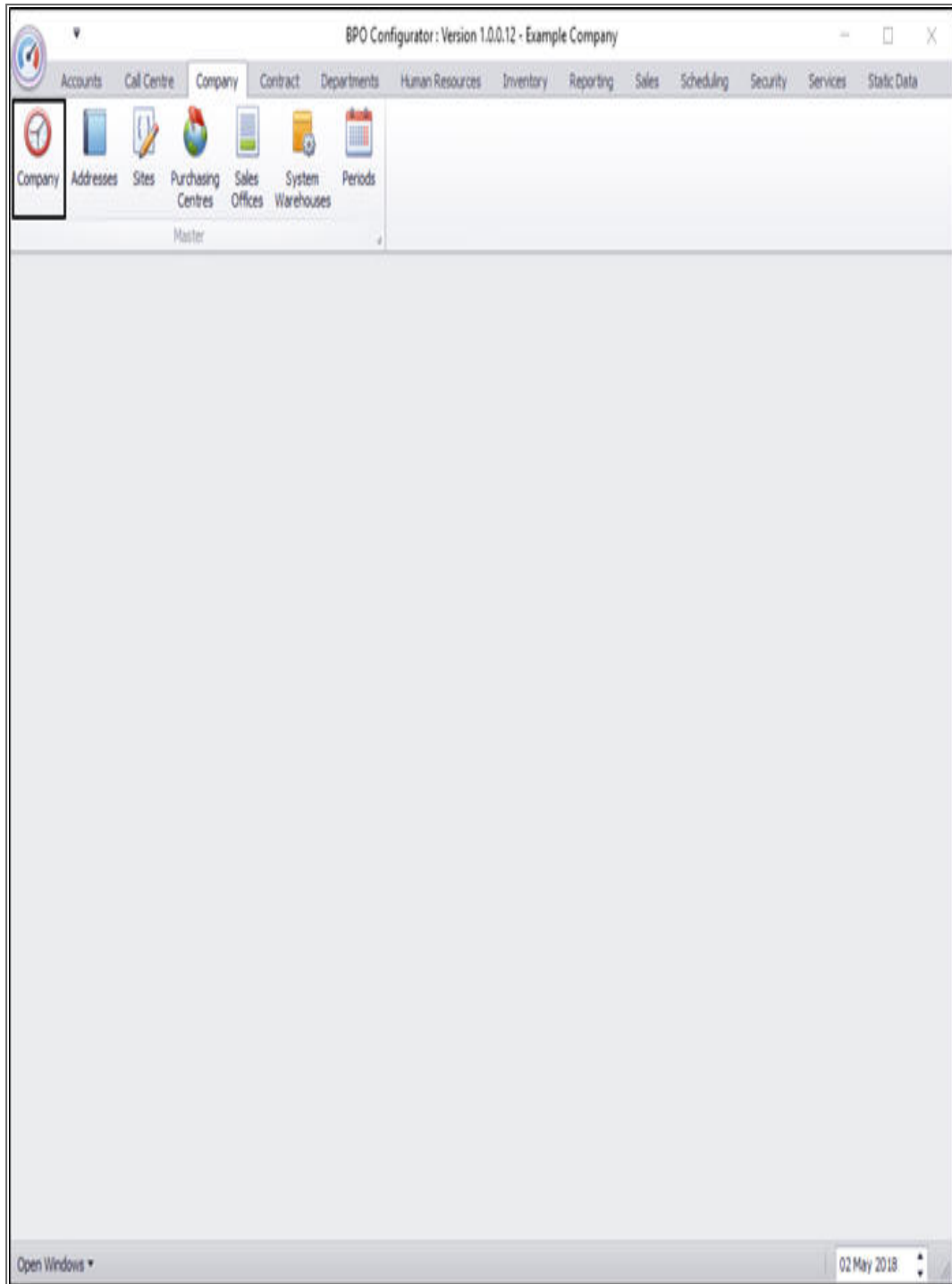
## COMPANY - SETTING UP TAX RATES

Tax rates need to be set up so that you can add tax to items e.g. **15%** VAT on stock sold.

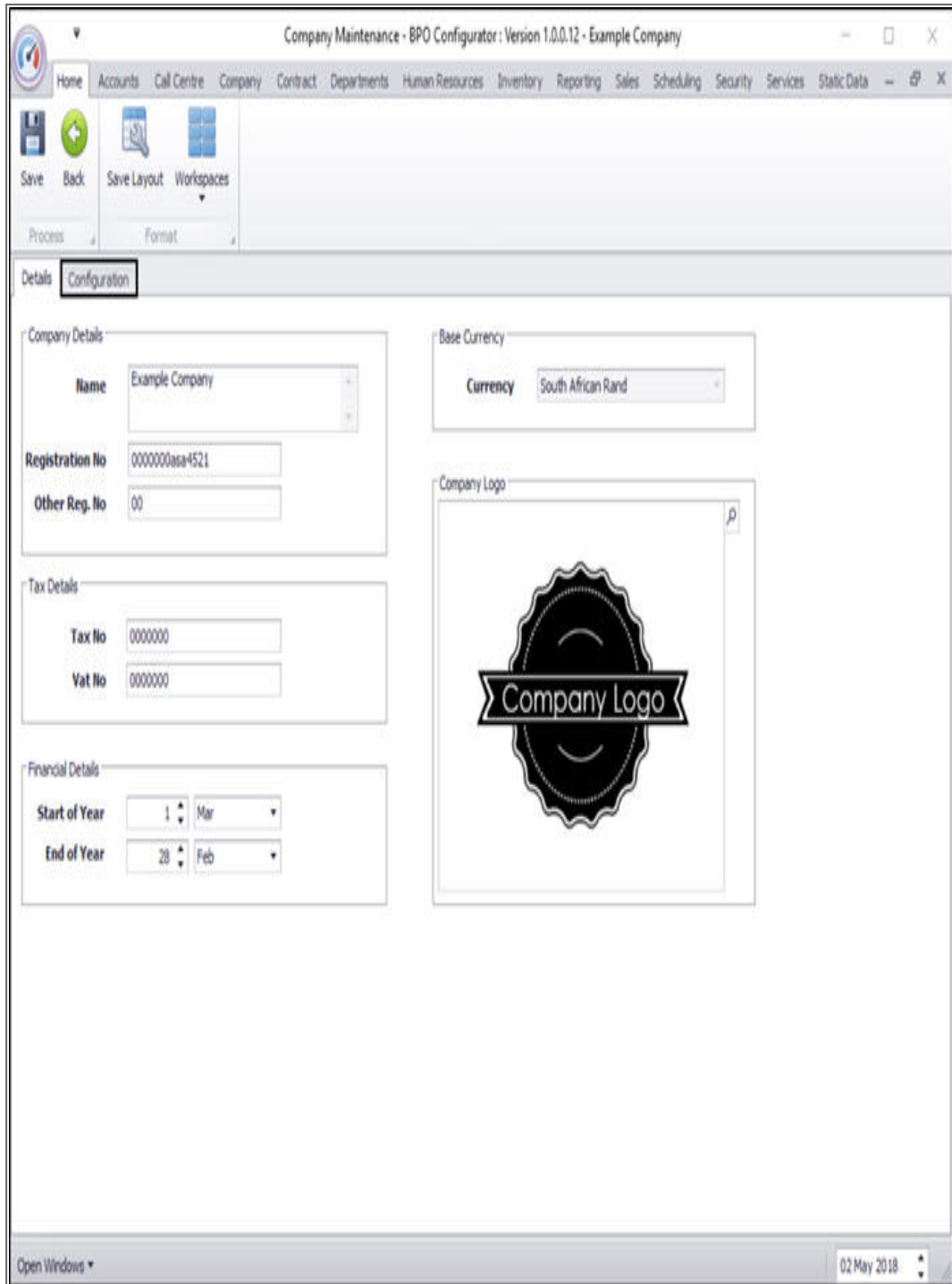

**Ribbon Access:** *Configurator > Company > Company*

- The **Company Maintenance** screen will be displayed.
- Click on the **Configuration** tab.



- You can now view the **Tax Rates** frame.
- **Right click** anywhere in a **row** of the **Tax Rates data grid**.

- A **Maintain** menu will pop up.
- Click on **Add** - Add New Tax Rate.

- Click on the **row selector** in front of the **tax code** that you wish to **link** to this company.
- Click on **Ok**.
