Ribbon Access: Nucleus Service > Reporting > All Reports



### **REPORTS - ACTIVITIES**

- 1. In the **Reports** listing screen;
- 2. Search for and select the **CRM** tree view icon.
- 3. The <u>CRM sub-report layer</u> will open, select the **Activities** tree view icon.
- 4. The <u>Activities sub-report layer</u> will open, select **Activity List** from the list of reports.




#### **CRM** Reporting

Sales people can be remunerated based on activities, and with this dashboard you can corroborate the activities done.






### **REPORTS - PIPELINE SUMMARY**

- 4. The <u>Opportunities sub-report layer</u> will open, select **Pipeline Summary** from the list of reports.



#### **CRM** Reporting
